

WHO OVERSEES INDIANA'S ENVIRONMENTAL REGULATIONS?

Environmental regulations in the state of Indiana are governed through the Indiana Department of Environmental Management (IDEM). The various compliance and permitting programs administered by IDEM receive their authority through the United States Environmental Protection Agency (U.S. EPA) and the Indiana General Assembly via Title 13 of Indiana Code. IDEM employs highly qualified engineers, scientists, and environmental project managers who specialize in air, land, and water quality issues and pollution prevention. These professionals work in partnership with the IEDC to provide a unified approach towards Indiana's business friendly environment.

WHAT DOES IDEM DO?

The mission of IDEM is to protect human health and the environment while allowing the environmentally sound operations of industrial, agricultural, commercial, and governmental actives vital to a prosperous economy.

WHICH KEY AREAS DOES IDEM OPERATE WITHIN?

The majority of permitting programs are divided among three quality offices: air, water, and land. Each quality office has an assistant commissioner and deputy commissioners that bring decades of experience to the forefront of their work. Additionally, IDEM has four regional offices that are part of their greater Office of Program Support. These regional offices serve as a conduit between the central state office and the residents, municipalities, and businesses located throughout the state.

HOW DOES IEDC FACILITATE PERMITTING NEEDS WITH IDEM?

Through the Indiana Business Ombudsman, the IEDC communicates regularly with IDEM to coordinate the best permitting paths for companies. While the IEDC cannot guarantee any permitting approvals, we can help process the necessary steps to ensure the permitting process is as smooth as possible. A benefit of Indiana's regulatory environment is that IDEM has no backlog on permit applications and is typically able to issue a final permit decision in advance of statutory deadlines.

GENERAL PERMIT PROCESS TIPS

(may be applicable to air, water, or land permit applications)

- 1. Hire an Environmental Consultant
 Environmental consultants are experts
 in their field and typically come from a
 regulatory or legal background. They
 will be able to assist companies in
 navigating the complex nature that is
 environmental regulation.
- 2. Meet with IDEM Ahead of Application Submission

IDEM, while a regulator, has shown time and again they seek to promote and foster a business-friendly environment in Indiana that allows them to also serve as the stewards of Indiana's environmental wellbeing. Putting faces with names and explaining overarching approaches from both sides before a permit application is officially submitted goes a long way ensuring goals can be achieved together.

3. Have Emission and Effluent Analysis Prepared Ahead of Time

Understanding industrial outputs and providing information in a timely manner to IDEM will help ensure the permitting process runs as efficiently as possible.

WHY INDIANA?
